Notice to Guiders and Leaders on
Cap.599L Prevention and Control of Disease (Vaccine Pass) Regulation
(Effective from 24 February, 2022)

The Hong Kong Girl Guides Association Headquarter, Campsites, Activity Centre, Badgework Centre, NTW Centre, IS Centre are regarding the regulated premises under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F). Below measures will be take effect on **24 February, 2022**.

1. Vaccine Pass

Prevention and Control of Disease (Vaccine Pass) Regulation (Cap. 599L) is which provides that from February 24 onwards, the Vaccine Pass will be applicable to (1) all catering business premises; and (2) scheduled premises specified in the Direction under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F). Anyone (included the public, parents, guiders / leaders, commissioners, trainers, instructors or other guide members) (except exemptions*) who need to enter Headquarters or Centres or Campsites (except Guides Shop) must comply with the requirement of the Vaccine Pass. Please present the QR Code for scanning upon Entry.

Only under the following circumstances* can one be exempted from the vaccination requirement. Exempted scenarios include:

- (A) children aged under 12;
- (B) holders of the COVID-19 Vaccination Medical Exemption Certificate (Exemption Certificate), He/She must present the Vaccination Medical Exemption Certificates QR code. For certificates without an encrypted QR code, please use *Declaration / Information Collection Form for Persons Entering Specified Premises of “Vaccine Pass”* to register;
- (C) the person enters Headquarters or Centres only for—
 - (i) only purpose of delivering or picking up of an article; or
 - (ii) performing necessary repairs.

2. Use the “LeaveHomeSafe” mobile application

All persons have to use LeaveHomeSafe mobile app to scan the venue QR code before entering. They also have to perform temperature check at the entrance. People with fever symptoms will not be permitted to enter. The following three categories of persons may use *Declaration / Information Collection Form for Persons Entering Specified Premises of “Vaccine Pass”* to register as an alternative to the use of the LHS mobile application:

- (a) persons aged 65 or above and aged 15 or below;
- (b) persons with disability; and
- (c) other persons recognised by the Government or organisation(s) authorised by the

Government for this purpose

For persons aged 15 or below entering a catering business premises or scheduled premises, he/she would not have to register his/her personal information using the specified form if he/she is accompanied by an adult who has complied with the LHS requirement (i.e. he/she has used the LHS mobile application or use the specified form to register relevant information as an alternative in accordance with the requirements).

3. Unit meetings/Activities

All guiders / leaders, commissioners or members (except exemption*) who enter Headquarter for unit meeting must comply with the requirement of the Vaccine Pass. If unit member's parent/ guardian/the person of pick-up, do not have COVID-19 vaccination, guiders/unit leaders should arrange pick up at the front door of Headquarter.

4. Delivery or pick-up at HKGGA Headquarters

For those who need to deliver items but cannot present the vaccine record/ medical exemption certificate, it is recommended to put the items into the collection box next to the ground floor security room with your contact number.

For those who need to pick-up items but cannot present the vaccine record / medical exemption certificate, please register at the security booth and wearing the visitor card within the headquarters building.

For Centres

Please submit or collect the items at the entrance.

5. HKGGA Guides Shop

All guests/visitors must scan the Guides Shop's "LeaveHomeSafe" QR code when you enter Guides Shop. For those who cannot present the vaccine record / medical exemption certificate, he/she is not allowed to enter other area of Headquarter apart from Guides Shop.

The above arrangements are referring to Cap. 599F Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation of Directions in Relation to Scheduled Premises and Cap.599L Prevention and Control of Disease (Vaccine Pass) Regulation. All unit meetings, activities, trainings arrangements, please refer to "HKGGA Special Announcement on Activity Arrangements" and "HKGGA Special Announcement on Activity and Venues Booking Arrangements under the Coronavirus Situation".
